# LONG HILL TOWNSHIP BOARD OF EDUCATION REGULAR MONTHLY MEETING JANUARY 24, 2011

The Long Hill Township Board of Education held a Regular Monthly Meeting on Monday, January 24, 2011 in the Long Hill Township Town Hall. The meeting was called to order by Board President Lisa Scanlon.

## ADEQUATE NOTICE OF MEETING:

Adequate notice of this meeting of the Long Hill Township Board of Education was given as required by the Open Public Meetings Act as follows:

Notice was sent to the Courier News, Echoes Sentinel and the Daily Record on April 27, 2010. Notice was posted on the bulletin board in the first floor entrance hall of the School District Administration Building, Gillette, New Jersey. Notices were filed with the Township Clerk; and notices were mailed to all persons who have requested individual notice pursuant to the Open Public Meetings Act.

### COMMUNICATIONS

Mrs. Scanlon received numerous phone calls and emails regarding the Horizon Program.

### BOARD COMMITTEE REPORTS

Negotiations – Mr. Meringolo will report on negotiations with the Administrators in private session.

Policy – Mr. Carbone reported there is one policy on for approval tonight and a committee meeting is scheduled for January 31.

Cost Containment Committee – Dr. Rae stated that he would like the committee to host a gathering of our local school districts to talk about shared services.

Finance – Mr. Blocker reported the committee met earlier and reviewed the bills and all is in order for payment. He also reported that our medical premium costs have increased to over \$120,000 per month or 25% in 2 years.

Mr. Blocker also discussed the Morris County School Boards Association meeting that he and Mrs. Scanlon attended, saying they were able to speak to our legislators about critical educational issues.

## SUPERINTENDENT'S UPDATE

Dr. Rovtar stated January is School Board Recognition Month and thanked the Board Members for volunteering a tremendous amount of time which helps the district to provide an excellent education for the students in Long Hill Township.

Dr. Rovtar attended the PTO meeting last week and thanked them for their generous donations of LCD and ELMO projectors. There was also a Cyber Safety Presentation by the Morris County Prosecutor's Office. She thanked Mr. Blinder for arranging this session.

Dr. Rovtar discussed the school calendar and making up snow days. There are several options available depending on the additional number of snow days we experience over the next few weeks. The Board discussed the possible approaches if the calendar must be adjusted.

Dr. Rovtar gave a presentation on Proposed Changes to Gifted and Talented Horizon Program.

The Board then asked questions about the proposed changes:

Mrs. Nyquist asked about the percentage of students in each class in Horizons. Mr. Carbone asked about studies on heterogeneous grouping versus homogeneous grouping.

Dr. Rae asked about the faculty's input on the issue and Dr. Rovtar responded.

Ms. Barone wanted to know why the students wouldn't be graded, and Dr. Rovtar noted that the activities would not be conducive to typical grading standards. She noted that we don't really have a Gifted and Talented Program right now, but are required to have one. Dr. Rae asked about "measuring" whether differentiating of instruction is taking place and whether it is effective

### COMMENTS FROM THE PUBLIC

At this point, the Board of Education welcomes comments from any member of the public. Please note that as per Board Policy #1120, a total of fifteen (15) minutes is allocated for public comments at any single Board meeting. In order to provide residents the opportunity to comment, individual speakers are limited to three minutes each at any particular Board meeting. The Board may extend these time limits at its discretion.

MRS. JHAVERI commented on heterogeneous versus homogeneous grouping. She wanted to know about the details of data on NJASK test scores.

MRS. BROWN read a speech about what "Horizons" means and why students should be at separate levels.

MR. HOWARD is concerned that one hour per week is not sufficient enough time to cover any complex subject.

RACHEL BROWN, former student, spoke in favor of the current Horizons Program and said it only affected her in a positive manner.

MR. KENNELLY read a prepared statement on how difficult it is to meet the needs of all children. He disagrees with the proposal of the Superintendent.

ASHIL JHAVERI, student, disagrees with getting rid of the Horizons Program.

MRS. PILSBURY spoke highly of Long Hill Township Schools but disagrees with getting rid of the Horizons Program. She agrees with just adding a Gifted and Talented Program to the current set-up.

MRS. SINNOT asked the Board to keep the program, saying her daughter benefited from it.

MRS. DEO has a 5<sup>th</sup> grader who excels in Horizons.

MR. DEO is against the proposal tonight. He doesn't feel that parents are being listened to and he questioned Dr. Rovtar's reply to an email a parent wrote today.

MRS. BOKACH is a teacher in another district and commented that other schools do have separate classes for accelerated students.

MR. KELLER has children in the program and is confused over the history of Horizons and the effect of the Gifted and Talented Program. He does not want to get rid of the current set-up.

MRS. WEISMAN wants to keep the Horizon Program and add a Gifted and Talented Program.

MRS. BROOKS wants the Board to expand the Horizon Program to include more students.

MRS. HOBBS has several children who have had different experiences.

MRS. DEO said that she agreed with Dr. Rovtar that a "one-size fits all" approach won't help all students.

MR. KELLER added that Horizon students have more than intellect, they have drive as well.

MR. GIANAKIS said that FORCE would be happy to work with parents to create enrichment classes/programs.

MRS. JHAVERI said her son is putting together a petition to send to Dr. Rovtar.

MRS. COLLINS saw both sides of the discussion and how it affected her own child. She thinks the students in the middle get hurt by not being in the Horizon Program.

#### BOARD SECRETARY UPDATE

Mr. Esposito stated that he will be providing a budget update to the Finance Committee members by the end of the week.

APPROVAL OF CHANGE IN BIDDING AMOUNT WHEREAS, NJAC 5:34-5.2 details the procedures for increasing the bid threshold and states in part, "A contracting unit with a qualified purchasing agent desiring to take advantage of the supplemental authority of N.J.S.A. 18A:18A-3 and 18A:18A-4.3 shall have its governing body pass a resolution authorizing the amount of a higher bid threshold for the contracting unit, the amount of which shall not exceed the statutory maximum bid threshold ... In a contracting unit subject to the Public School Contracts Law, a certified resolution increasing the bid threshold shall be filed with the Director of the Division of Local Government Services in the Department of Community Affairs and shall be accompanied by a copy of the contracting unit's purchasing agent's qualified purchasing agent certification", and

WHEREAS, P.L. 2009, c. 166 took effect on January 1, 2011 and changes the maximum allowable bid threshold for a qualified purchasing agent to \$36,000. Now therefore be it

RESOLVED, that the Qualified Purchasing agent shall, effective as of this date, be authorized to purchase goods and services without bidding in amounts not to exceed \$36,000 in the aggregate and is authorized to purchase goods and service without quoting in amounts not to exceed \$5,400 in the aggregate.

BE IT FURTHER RESOLVED, that the board secretary is authorized and directed to submit to the Director of the Division of Local Government Services in the Department of Community Affairs a copy of this resolution and a copy of the Qualified Purchasing Agent's certification.
