BOARD SECRETARY'S UPDATE

Mr. Esposito stated that a notice has been received from the State Employees Health Benefits Commission indicating that the district's health benefits premiums will be increasing by 10% effective January 1, 2012. Item #6 on the agenda involves the establishment of a Premium Option Plan and Flexible Spending Account as required by law. This plan will go into effect on July 1, 2012. The approval of item #7 will close the Board's two sweep bank accounts. Since all of the Board accounts are now earning the same rate of interest, the sweep account is no longer necessary.
