LONG HILL TOWNSHIP BOARD OF EDUCATION REGULAR MONTHLY MEETING FEBRUARY 27, 2012

The Long Hill Township Board of Education held a Regular Monthly Meeting on Monday, February 27, 2012 in the Long Hill Township Town Hall. The meeting was called to order by Board President Lisa Scanlon at 7:30 p.m.

PLEDGE OF ALLEGIANCE: Mrs. Scanlon led the Pledge of Allegiance.

ADEQUATE NOTICE OF MEETING:

Adequate notice of this meeting of the Long Hill Township Board of Education was given as required by the Open Public Meetings Act as follows:

Notice was sent to the Courier News, Echoes Sentinel and the Daily Record on May 3, 2011. Notice was posted on the bulletin board in the first floor entrance hall of the School District Administration Building, Gillette, New Jersey. Notices were filed with the Township Clerk; and notices were mailed to all persons who have requested individual notice pursuant to the Open Public Meetings Act.

COMMUNICATIONS: None.

BOARD COMMITTEE REPORTS

Finance – Mr. Blocker reported the committee met before this meeting to discuss the proposed tentative 2012-13 budget and they unanimously support the budget as put together by the administration. Mr. Blocker believes it balances the needs of the children and the concerns of the taxpayer. Mr. Blocker also noted that there are no staff reductions planned for next year.

The committee also reviewed the bills and found all in order for payment.

Mr. Blocker thanked Mr. Rideout for putting together the Long Hill's Got Talent Show which raised funds for the school district.

Policy – Mr. Carbone reported the committee will meet on March 5 at 6:15 p.m.

Negotiations – Mr. Russo reported the committee will be meeting with the LHEA soon to initiate the negotiations process.

WHRHS Liaison – Mrs. Nyquist attended the Watchung Hills Board Meeting and said that Mr. Collins is replacing Mr. Pepe who resigned from the Board. They also did a preliminary presentation of the budget for 2012-2013. They expect enrollment to rise and will need to hire staff to handle the increased number of students.

SUPERINTENDENT'S UPDATE

Dr. Rovtar stated the district talent show was truly delightful. She also reported that the District Advisory Committee attended a full day workshop on the four approved teacher evaluation models. The committee will review the details and make a recommendation to the Board regarding which model Long Hill Township should implement.

Dr. Rovtar then turned the meeting over to Mr. Esposito to present the tentative 2012-13 budget.

BOARD SECRETARY'S UPDATE

Mr. Esposito presented a Power Point on the tentative 2012-13 budget. The PowerPoint will be posted on the main page of the district website. The overall current fund expenditure increase from year to year is 3.49%. This increase reflects that the Board will appropriate \$250,000 from Capital Reserve for roof and energy management projects. Without the Capital Projects, the increase in the operating budget is 2.0%. The district received a net increase in state aid of \$88,197. The projected tax levy change between the 2011-12 and 2012-13 budgets is a decrease of 0.23%. The total assessed valuation in the Township has decreased slightly resulting in a moderate increase in taxes. The proposed budget would increase taxes by \$56.23 annually (\$4.69 per month) for the average assessed home in Long Hill (\$387,822). The budget will be submitted to the County Office for review and approval. A public hearing on the budget has been scheduled for March 26th.

Mr. Esposito reported that he was working with the financial advisor on the refunding bond sale today. The results were better than anticipated with the overall savings being approximately \$771,000 or \$45,000 annually. The bonds received a AA- rating from Standard and Poors. Once these numbers are confirmed, we should be able to reduce the Debt Service tax levy in the proposed budget. That could be done at the Public Hearing on March 26.

COMMENTS FROM THE PUBLIC

At this point, the Board of Education welcomes comments from any member of the public. Please note that as per Board Policy #1120, a total of fifteen (15) minutes is allocated for public comments at any single Board meeting. In order to provide residents the opportunity to comment, individual speakers are limited to three minutes each at any particular Board meeting. The Board may extend these time limits at its discretion.

There were no comments from the public.

BE IT FURTHER RESOLVED, that there should be raised for the General Fund \$13,841,574.00 and for Debt Service \$1,244,143.00 for the ensuing School Year 2012-13; and

WHEREAS, the district has a taxing authority which is composed of \$0.00 for health benefits adjustment and \$0.00 for enrollment adjustment and \$0.00 for PERS Deferment available to the district for the school budget for 2012-13.

The 2% cap increase over the prior year, which totals \$277,476.00, results in a maximum district general fund tax levy of \$14,151,297.00. The proposed negative tax levy for 2012-2013 generates an additional \$32,247.00 in unused taxing authority, resulting in a total banked cap amount of \$309,723.00 for the district.

WHEREAS, The Board has approved that there should be raised for the General Fund a tax levy of \$13,841,574.00 for the ensuing School Year (2012-2013).

BE IT RESOLVED, that the Long Hill Township School District Board of Education, in the County of Morris, New Jersey approves that the unused taxing authority of \$309,723.00 be banked for potential use in the subsequent three fiscal years.

BE IT RESOLVED, that the Long Hill Township School District Board of Education, in the County of Morris, New Jersey approves the withdrawal of \$250,000.00 from the Capital Reserve to provide funding for the following Projects:

- District-wide replacement and repair of aging, leaking roofs (including professional fees, bidding costs, etc.): \$150,000
- Development and installation of district-wide energy management system (including professional fees, bidding costs, etc.): \$100,000

BE IT FURTHER RESOLVED, that the Long Hill Township School District Board of Education, in the County of Morris, New Jersey approves the following capital projects for the 2012-2013 school year:

- -Assessment on prior referendum projects (State mandatory deduction): \$33,181.
- -District-wide replacement and repair of aging, leaking roofs (including professional fees, bidding costs, etc.): \$150,000
- -Development and installation of district-wide energy management system (including professional fees, bidding costs, etc.): \$100,000

WHEREAS, school district policy and N.J.A.C. 6A:23A-7.3(a) provides that the board of education shall establish in the annual school budget a maximum expenditure amount that may be allotted for such travel and expense reimbursement for the 2012-2013 school year; and

WHEREAS, maximum expenditure amount allotted for travel and expense reimbursement for the 2011-2012 school year was \$30,000.00; and

WHEREAS, travel and expense reimbursement has reached a total amount of \$16,000.00 as of March 1, 2012;

BE IT RESOLVED, that the Long Hill Township School District Board of Education, in the County of Morris, New Jersey hereby establishes the school district travel maximum for the 2012-2013 school year at the sum of \$30,000.00; and

BE IT FURTHER RESOLVED, that the School Business Administrator shall track and record these costs to insure that the maximum amount is not exceeded.

WHEREAS, N.J.A.C. 6A:23A:5.2 (a) mandates boards to establish annually prior to budget preparation, for public relations and each type of professional service a maximum level of spending for the ensuring school year; and

WHEREAS, the tentative budget includes the following appropriations

WHEREAS, the Administration needs to notify the board if there arises a need to exceed said maximum amount through formal board action; and

WHEREAS, the Board and Administration wishes to minimize the amount of paperwork involved in this area;

BE IT RESOLVED, that the Long Hill Township School District Board of Education, in the County of Morris, New Jersey establishes maximums for professional services in the areas listed above at a level of 120% of the amounts listed for the 2011-2012 school year.

It is duly noted that this budget represents an increase of 3.49% in general fund appropriations and a 0.23% <u>decrease</u> in the general fund tax levy.
