The Long Hill Township Board of Education held a Worksession on Monday, April 9, 2012 in the Long Hill Township Town Hall. The meeting was called to order by Board President Lisa Scanlon at 7:30 p.m.

ADEQUATE NOTICE OF MEETING

BOARD COMMITTEE REPORTS

Morris County Ed. Services Comm. – Miss Nyquist reported that due to declining enrollment at the 2 schools operated by the Ed. Services Commission, they will be consolidating some of the enrollment. They will also be looking at a reduction in force due to declining enrollment. The commission budget reflects a 0% increase in salaries.

Policy – Mr. Carbone reported that the committee met on April 2. He thanked Dr. Rovtar for her work with the committee. Mrs. Scanlon said that it is wonderful that all of the district policies will now be available online. She thanked Mr. Carbone for his leadership on the committee.

Curriculum – Ms. Barone stated that the committee will be meeting on April 24th. Mr. Carbone raised a question about a mailing the board members had received from ACT for America on the treatment of Islam in 6th through 12th grade textbooks. Dr. Rovtar indicated that the administrators had not received a copy of this report. She will review it and report back to the Board.

SUPERINTENDENT'S UPDATE

Dr. Rovtar reported that there is a resolution on the agenda to approve the submission of a grant application for the Excellent Educators for New Jersey funding that will be made available by the New Jersey Department of Education for implementation of the new teacher evaluation model. The district has contacted St. Vincent de Paul as well as the other 4 districts in the Watchung Hills region to explore the possibility of forming a consortium to apply. If a consortium is not formed, the Long Hill School District will submit an individual district application.

Millington School

Mrs. Dawson reported on the following:

The Board discussed the proposed calendar for 2013-14. Mr. Meringolo asked if the inservice days for the teachers could be scheduled prior to Labor Day. Dr. Rovtar explained that the regional districts try to coordinate the calendars as much as possible and not all of the labor contracts in the districts permit scheduling work days for the teachers prior to September 1. There are 4 snow days built into the calendar. Days in excess of the 4 would be made up by scheduling school on days such as Martin Luther King Day or taking days away from the April vacation.

OLD BUSINESS

Mrs. Scanlon reminded the Board that the April 23 meeting will start at 7:00 p.m. with a half hour private session with Joanne Borin to review the Superintendent's evaluation. The regular meeting will start at 7:30 p.m. Dr. Rovtar stated that Ms. Borin will also be able to do the annual goal setting with the Board at the June 11th meeting.

NEW BUSINESS

Miss Nyquist stated that the Community Relations Committee will be trying to get more coverage of the district in the Star Ledger. She asked the principals if all of the press releases about school activities go through their offices. The principals indicated that sometimes the PTO or FORCE submit press releases about events and activities directly to the newspapers.
