#### BOARD COMMITTEE REPORTS

Curriculum – Ms. Barone stated there is a resolution on the agenda to approve new math textbooks for grades Kindergarten through 5. She discussed the advantages and attributes of the chosen books.

Policy – Mr. Carbone stated there are a number of policies on the agenda which have been reviewed by the committee and are recommended for readoption.

Watchung Hills High School Liaison – Mr. Carbone attended a meeting of the WHRHS Board of Education. He reported there are 475 seniors this year and there will be 535 next year. The art program continues to grow.

Finance – Mr. Blocker reported the committee did not meet this evening but he reviewed the financial reports on the agenda and recommends resolutions 2, 3, 4 and 5 for approval.

Negotiations – Mr. Russo stated he will present a report to the Board in private session. He is hopeful that an agreement may be reached prior to June 30.

SPORT Liaison – Mr. LoCascio attended the SPORT meeting and reviewed some of their activities. The group is sponsoring the annual Patriots Game fund raiser which will be on June 16.

#### SUPERINTENDENT'S UPDATE

Dr. Rovtar reported that the NJ Teachers of Speakers of Other Languages recently ran an essay contest. One of our Central Middle School students was awarded first place honors for the essay submitted. The student will be honored at their Spring Conference and will receive a laptop computer.

The district's applications for each of the three schools to receive an energy audit have been approved by the state. Proposals from prospective firms are due by June 1.

Planning for implementation of the new Teacher Evaluation System is moving ahead. Training for the administrators is scheduled for late June.

##### Central School

- The music trip to see the New York Philharmonic will take place on May 24. Students will visit Avery Fischer Hall and listen to a performance of Aaron Copeland's "Billy the Kid" as well as participate in a clinic by the Philharmonic.
- A parent meeting for the 8<sup>th</sup> grade trip to Washington D.C. will be held on May 24 at 7:00 p.m.

- Orientation for 5<sup>th</sup> grade students who will be attending Central School in September will be on May 31. A meeting for the parents will be held that evening.

### Millington School

Mrs. Dawson reported on the following:

- Students in grade 3 through 5 had their NJASK testing the week of April 30 –May 4.
- Second grade students had PTO sponsored Environmental Day activities over the last week of April and first week of May. The activities included a visit by the Raptor Trust and a trip to the Great Swamp.
- Fourth grade students are going to Trenton tomorrow. Assemblyman Bramnick will be talking to the students about how a bill becomes a law in the statehouse.
- Fifth grade students will be going to the Newark Museum. This trip is funded through a grant from FORCE.
- May 22 is the 5<sup>th</sup> grade Character Education Day.
- May 24 is 5<sup>th</sup> grade Colonial Day.
- May 31 is the 1<sup>st</sup> and 5<sup>th</sup> grade student orientation.
- June 5<sup>th</sup> is the 4<sup>th</sup> grade science fair.
- Field Day is scheduled for June 8.
- The PTO has scheduled a muralist to come in next week. All students will be painting a character education mural during their art time in the all purpose room. Thank you to the PTO for supporting this initiative.

Dr. Jones reported on the following:

### Curriculum

- Two training sessions were held today for teachers. In the morning kindergarten teachers were trained on the Reading Street Program. In the afternoon the teachers in grades kindergarten through 5 were trained in the EnVision Math Program.
- Today was also one of the Curriculum Mondays, with teachers being given time to work on their curriculum mapping after school.
- On May 16 Dr. Jones will be attending the Long Hill Moms Club and speaking about Gillette School and the Kindergarten and 1<sup>st</sup> grade curriculum.
- May 29 will be a grades 4-8 math collaborative meeting to discuss the changes between the grade levels with the new Common Core Standards.

### Gillette School

- Field Day was last Friday. Dr. Jones thanked all the parents who helped.

- Dr. Jones thanked the parent volunteers for a wonderful Teacher Appreciation Lunch last week.
- On May 3 the kindergarten classes took their field trip.
- May 24 will be the Gillette School Parent Volunteer Celebration.
- There will be a planned evacuation on May 24.
- On May 29 the Tiger Scouts will wear their uniforms to school and visit the kindergarten classes.

- Dr. Jones congratulated Mrs. Dobiszewski on presenting at the International Reading Association Conference in Chicago last week. Mrs. Dobiszewski's workshop was titled "From Hearing Loss and Beyond: Strategies for Students with a Secondary Disability".
- Kindergarten screening will be on June 4 and 11.
- Kindergarten summer send off will be on June 7.
- The first grade field trip to the Red Mill Museum is on June 15.
- The End of the Year Social is on June 19 from 6:00 to 8:00 p.m. at the back of Gillette School.

#### BOARD SECRETARY'S UPDATE

Mr. Esposito reported on the following:

- Morris County School Boards Association will be having a meeting on May 17 at Madison High School. Board Members need to register by Wednesday to attend.
- Information on becoming a candidate for the Board of Education is available on the NJ School Boards website – [www.njsba.org](http://www.njsba.org). Candidate petitions must be submitted to the Morris County Clerk by 4:00 p.m. on June 5.
- Mr. Esposito discussed the Alliance for Competitive Energy Services (ACES), the cooperative energy purchasing program organized by NJ School Boards. For next year there will be a 32% savings on electricity and a 16% saving on natural gas. There are 416 districts that belong to ACES. This gives the group a strong base for very competitive pricing on energy.
- Mr. Esposito indicated that he will discuss the MUJC transportation routes for the 2012-2013 school year at the next meeting.

The Roots Program will provide Central Middle School with a fully funded intervention that uses social scientific insights for improving a school's social climate and reducing HIB behavior. The intervention will track the HIB climate at CMS using student surveys that are administered to all students three times throughout the school year as well as teacher surveys. All information collected in the program will remain confidential. All reports will reference students and teachers with random identification numbers. Small groups of student leaders will also participate in a training program to discourage HIB behavior within their school friendship groups and online, and to role model inclusive, tolerant behavior. The program is based on extensive social scientific research and previous piloting of this program in other public middle and high schools.
