Additionally, families with past due Comcast debt older than one year are now eligible for the program. Comcast will offer amnesty for that debt for the purpose of connecting to Internet Essentials, so long as the customer meets all the other eligibility criteria.
- Reflecting our diverse communities: English and Spanish-speaking families may call our dedicated in-language call centers, or apply online at InternetEssentials.com or InternetBasico.com. Materials for Internet Essentials are available in 12 languages beyond English and Spanish, such as Somali, Chinese, Korean, and Russian.
- Increased speeds twice in two years: We now offer up to 5 Mbps downstream, more than triple the speed offered at the beginning of the program.
- Learning anywhere, anytime: Comcast is committed to ensuring that learning not only happens in school and at home, but also continues in the community, at rec centers, libraries, and after-school programs.
