# LONG HILL TOWNSHIP BOARD OF EDUCATION REGULAR MEETING January 20, 2014

The Long Hill Township Board of Education held a Regular Meeting on Monday, January 20, 2014 in the Long Hill Township Town Hall. The meeting was called to order by Board President Rita Barone at 7:30 p.m.

PLEDGE OF ALLEGIANCE: Ms. Barone led the Pledge of Allegiance.

### ADEQUATE NOTICE OF MEETING:

Adequate notice of this meeting of the Long Hill Township Board of Education was given as required by the Open Public Meetings Act as follows:

Notice was sent to the Courier News, Echoes Sentinel and the Daily Record on January 7, 2014. Notice was posted on the bulletin board in the first floor entrance hall of the School District Administration Building, Gillette, New Jersey. Notices were filed with the Township Clerk; and notices were mailed to all persons who have requested individual notice pursuant to the Open Public Meetings Act.

COMMUNICATIONS: Dr. Rovtar indicated that she had received a letter from Mrs. Maryann Infantini regarding her intention to retire at the end of the current school year.

#### **BOARD COMMITTEE REPORTS**

Finance – Mr. LoCascio stated that the Finance Committee met this evening with Mr. Esposito to review the preliminary 2014-2015 school district budget. He explained the budget process going forward and noted the Board is scheduled to approve a tentative budget at the February 24, 2014 meeting. Mr. LoCascio noted that the district's referendum election is scheduled for March 11, 2014. Mr. LoCascio reported all the bills are in order and Finance Item #2 is recommended for approval.

Buildings and Grounds Committe - Mr. Blocker reported that the Buildings and Grounds Committee

met this evening and also discussed the referendum. He noted the importance of the projects, from a health and safety standpoint, that will be completed using grant funds. One of the district's existing bond issues is being retired and those savings will compensate for the new bonds to be issued if the referendum is approved, so there would be no net tax increase in terms of debt service.

Morris County Educational Services Commission – Ms. Nyquist reported that she attended the last meeting. They were in the midst of budget preparation and had sent a schedule of their new rates to all Morris County School districts. Some rates increased slightly but most were unchanged.

Curriculum Committee – Ms. Nyquist stated that the Curriculum Committee reviewed the Scope and Sequence for Keboarding and recommends its approval this evening. Mr. Stevens noted Ms. Nyquist had circulated the information and all Board members reviewed it.

PTO Liaison – Mr. Carn indicated there are three major upcoming events: "Long Hill's Got Talent" on January 31<sup>st</sup>, Bingo Night on February 21<sup>st</sup> and a Harlem Wizards Game on March 28<sup>th</sup> where faculty will play the Harlem Wizards.

Music Program – Mr. Stevens noted a fundraiser for the Central Middle School Music Program will be held on February 8, 2014 at Rolf's and his band will be one of two playing that night. Mr. Carn stated that the music program thanked the Board and the PTO for the new risers that were used for the Millington School Chorus concert last week.

FORCE Liaison –Mr. DiGiorgio reported that registration is open for upcoming classes and there is a new program available at Central School.

#### SUPERINTENDENT'S UPDATE

Dr. Rovtar indicated that information on the referendum is available on the main page of the district website. She said that a copy of the missing person flyer for David Bird can be downloaded from the main page of the district website. Dr. Rovtar noted that there may be an early dismissal tomorrow due to the impending snowfall but she will continue to monitor the situation and will send out an alert.

#### BUSINESS ADMINISTRATOR/BOARD SECRETARY'S UPDATE

Mr. Esposito reminded the Board members that:

- 1. Their online disclosure forms must be completed by February 1st. Members should check their Long Hill email accounts for a notification email from the School Ethics Commission.
- 2. He must register everyone for their required training, which can be completed online or at a workshop, so they should notify him of their preference.

Mr. Esposito stated that the new filing date for petitions to run for a Board seat in the November election is the last Monday in July. Mr. Esposito noted that with regard to the referendum, the debt service aspect of the district budget is not subject to the 2% cap. The debt service component of next year's budget, even with a new bond issue if the referendum is approved, would still be lower than the current year amount due to the retirement of one of the district's outstanding bond issues this year.
