LONG HILL TOWNSHIP BOARD OF EDUCATION WORKSESSION MEETING October 28, 2013

The Long Hill Township Board of Education held a Worksession Meeting on Monday, October 28, 2013 in the Long Hill Township Town Hall. The meeting was called to order by Board President Lisa Scanlon at 7:30 p.m.

Adequate notice of this meeting of the Long Hill Township Board of Education was given as required by the Open Public Meetings Act as follows:

Notice was sent to the Courier News, Echoes Sentinel and the Daily Record on January 3, 2013. Notice was posted on the bulletin board in the first floor entrance hall of the School District Administration Building, Gillette, New Jersey. Notices were filed with the Township Clerk; and notices were mailed to all persons who have requested individual notice pursuant to the Open Public Meetings Act.

COMMUNICATIONS: Dr. Rovtar stated that five residents applied for the Board of Education seat vacated by Bruce Meringolo.

INTERVIEW OF CANDIDATES FOR BOARD MEMBER VACANCY: Mrs. Scanlon read a statement regarding the interview process for the open Board seat. Each candidate would be asked the same questions. She noted that the open term is for one year, with two other three-year terms open in the next election.

The Board interviewed five candidates for the vacant seat on the Board of Education: Robert Biswanger, David Carn, Matthew DiGiorgio, Marlene Gebauer, and Marta Moakley. Each candidate responded to the Board members' questions.

BOARD COMMITTEE REPORTS

Buildings and Grounds- Mr. Russo updated the Board on the Central School roof project, which is almost complete. He stated that the Nurse's Office at Central School will be renovated over the summer, and the library will be reconfigured to provide for a separate computer lab area that would be more conducive to testing. The architect continues to work on the proposed referendum; the Board will know more after ROD grants are announced in early December.

NJSBA-Ms. Nyquist reported that she had attended the fall workshop and attended a session on community relations. She will be meeting with Dr. Rovtar to review some of the suggestions given.

Policy – Ms. Barone reported that there are a number of policies that are recommended for readoption this evening.

SPORT – Mr. LoCascio stated that he was unable to attend the meeting last week. He will obtain the minutes from the meeting and report any important information to the Board.

SUPERINTENDENT'S UPDATE

Dr. Rovtar stated that she is very excited that Halloween will be celebrated in the district this year! She noted that parent teacher conferences will take place next Monday, Tuesday and Wednesday and she encouraged parents to take advantage of this opportunity to discuss their child's progress with the teachers. She also indicated that a new link has been posted on the district website which she encouraged parents to review, as it provides sample items from the PARCC tests in English language arts and mathematics that will be administered to students beginning in the 2014-2015 school year.
