LONG HILL TOWNSHIP BOARD OF EDUCATION REGULAR MEETING February 24, 2014

The Long Hill Township Board of Education held a Regular Meeting on Monday, February 24, 2014 in the Long Hill Township Town Hall. The meeting was called to order by Board President Rita Barone at 7:30 p.m.

COMMUNICATIONS: None.

BOARD COMMITTEE REPORTS

Educational Services Commission of Morris County – Miss Nyquist reported that the February meeting and the make-up date had both been cancelled due to snow. The Board will have its next meeting in March.

Policy Committee – Miss Nyquist stated that there are a number of policies on the agenda for approval this evening. These policies have been updated in accordance with the New Jersey School Boards Association Critical Policy Reference Manual and are recommended for approval.

Buildings and Grounds Committee – Mr. Blocker reported that the Buildings and Grounds Committee met this evening to discuss two potential projects at Central School. He read the

descriptions from the architect. The projects being discussed were an expansion of the nurse's suite and a reconfiguration of the media center.

Finance – Mr. LoCascio stated that the Finance Committee met this evening. The committee reviewed the bills and payrolls. Everything is in order and resolution #2 is recommended for approval this evening. The referendum project was discussed and the vote is scheduled for March 11, 2014. The projects received grants from the state to cover forty percent of the costs. With the release of state aid figures in three days, the budget can be finalized so that the Board can vote on it at its March 3, 2014 meeting.

Watchung Hills Regional High School Liasion – Mr. Stevens attended the February 18th meeting and reported that a student spoke about the Robotics Rodeo that had been held. The Board honored two retirees.

FORCE – Mr. DiGiorgio reported that the TREPS program is for entrepreneurs. This afterschool enrichment class at Central School will help guide students through product development and marketing. Mr. DiGiorgio also stated that tickets are available for the Harlem Wizards game on Friday, March 28th.

PTO Liaison – Ms. Barone reported that the PTO Bingo Night, held this past Friday evening, was very successful. It was a sold out event that raised approximately \$20,000.

SUPERINTENDENT'S UPDATE

Dr. Rovtar reported on the following:

- The referendum vote will take place on Tuesday, March 11, 2014. The referendum will provide the local share of funding for the Millington roof project and HVAC improvements.
- This evening, the Board will be accepting the resignation of Mrs. Magee, for purposes of retirement, effective at the end of this school year. She thanked Mrs. Magee for more than 25 years of service to the children of Long Hill Township.

BUSINESS ADMINISTRATOR/BOARD SECRETARY'S UPDATE

Mr. Esposito reported that the tentative 2014-2015 budget will be presented at the next meeting on March 3rd. The tax levy is expected to be below the 2 percent cap.
