COMMUNICATIONS: Dr. Acevedo congratulated Mrs. Lunardoni and Mrs. Gray on their retirements.

## BOARD COMMITTEE REPORTS

Finance Committee – Mr. Bundonis noted that the Bills were reviewed and all Financial resolutions are recommended for approval.

Policy Committee– Mrs. Moakley noted that several policy and job description items are on tonight's agenda.

Educational Services Commission of Morris County – Miss Nyquist provided an update on the events of its recent meeting and noted that the Commission has picked up three schools from other counties.

Curriculum Committee – Mrs. Butler stated that the Committee met and she mentioned the topics covered at the meeting.

Buildings and Grounds Committee– Mr. DiGiorgio stated that the Committee met and reviewed the two RFP submissions. On Wednesday, a meeting is scheduled with the two firms to interview their proposed on-site managers and get answers to questions related to their RFP responses.

FORCE– Mr. DiGiorgio stated that the Robotics team placed in fourth at the competition in Nebraska. He congratulated the students and Coach Hadzic.

# SUPERINTENDENT'S UPDATE

Dr. Acevedo reported on the following:

-The District will be updating its STEM program. Input from teachers was wonderful. The program will be expanded to cover grades 2 through 8.

-He reported on the number of students currently enrolled in each grade including the 91 students already enrolled for September's kindergarten class. He stated that the district is looking at adding another class due to the enrollment figures.

-He introduced three Long Hill students who talked about the STEM block program.

# BUSINESS ADMINISTRATOR UPDATE

Mr. Esposito reported on the following:

-He indicated that he had been working on the budget, which would constitute his report for this evening. He and Dr. Acevedo then presented an overview of the proposed Budget to the Board. -Mr. Esposito thanked the Finance Committee members for their work in the budget development and review process.

Mr. Stevens opened the floor to comments from the public on the 2017-2018 budget. There were no comments from the public.

## ADOPTION OF THE 2017-2018 BUDGET

RESOLVED, that the Long Hill Township School District Board of Education, in the County of Morris, New Jersey approves the 2017-18 school district budget as follows:

BE IT FURTHER RESOLVED, that there should be raised for the General Fund \$14,942,669.00 and for Debt

Service \$1,100,638.00 for the ensuing School Year 2017-18; and

The 2.0% cap increase over the prior year, which totals \$292,993.00, results in a maximum district general fund tax levy of \$14,942,669.00.

WHEREAS, The Board has approved that there should be raised for the General Fund a tax levy of \$14,942,669.00 for the ensuing School Year (2017-2018).

BE IT RESOLVED, that the Long Hill Township School District Board of Education, in the County of Morris, New Jersey approves that the unused taxing authority of \$47,746.00 be banked for potential use in the subsequent three fiscal years. The district has a total banked cap of \$285,963.00 for use in 2017-2018.

BE IT FURTHER RESOLVED, that the Long Hill Township School District Board of Education, in the County of Morris, New Jersey approves the following capital projects for the 2017-2018 school year:

• Assessment on prior referendum projects (State mandatory deduction): \$33,181

WHEREAS, school district policy and N.J.A.C. 6A:23A-7.3(a) provides that the board of education shall establish in the annual school budget a maximum expenditure amount that may be allotted for such travel and expense reimbursement for the 2017-2018 school year; and

WHEREAS, maximum expenditure amount allotted for travel and expense reimbursement for the 2016 2017 school year was \$30,000.00; and

WHEREAS, travel and expense reimbursement has reached a total amount \$14,550.00 as of April 1, 2017;

BE IT RESOLVED, that the Long Hill Township School District Board of Education, in the County of Morris, New Jersey hereby establishes the school district travel maximum for the 2017-2018 school year at the sum of \$30,000.00; and

BE IT FURTHER RESOLVED, that the School Business Administrator shall track and record these costs to insure that the maximum amount is not exceeded.

WHEREAS, N.J.A.C. 6A:23A:5.2 (a) mandates boards to establish annually prior to budget preparation, for public relations and each type of professional service a maximum level of spending for the ensuring school year; and

WHEREAS, the tentative budget includes the following appropriations:

WHEREAS, the Administration needs to notify the board if there arises a need to exceed said maximums,

upon which the board may adopt a dollar increase in the maximum amount through formal board action; and

WHEREAS, the Board and Administration wishes to minimize the amount of paperwork involved in this area;

BE IT RESOLVED, that the Long Hill Township School District Board of Education, in the County of Morris, New Jersey establishes maximums for professional services in the areas listed above at a level of 120% of the amounts listed for the 2017-2018 school year.

It is duly noted that this budget represents an increase of 1.99% in general fund current appropriations and a 2.00% increase in the general fund tax levy.
