SUPERINTENDENT'S UPDATE

Dr. Acevedo reported on the following:

- -He attended the Graduation at Central School on 6/22. 111 students graduated. He thanked the PTO for sponsoring the refreshments and Mr. Villar and the entire Central School team for their hard work.
- -The school website is being updated with information about voluntary summer work for K-5 students. The required summer work for Central School students is on the website.
- -The phone and wireless upgrades are underway. Please be patient with any potential interruptions resulting from this important work.
- -He discussed that the Governor has proposed a major change to the way in which the state distributes school funding.
- -On 7/20, the Board will hold its annual retreat where it will work on goal development.
- -He and the administrators are meeting in July with the NJ Dept. of Education to discuss the new requirements for Student Growth Objectives and proposed changes to the AchieveNJ law.

BUSINESS ADMINISTRATOR UPDATE

- -He completed, certified, and submitted the annual Debt Service report to the NJ Dept. of Education.
- -He stated that those interested in running for a Board seat in November must send in their petition to the County Clerk by the last Monday in July.
