# LONG HILL TOWNSHIP BOARD OF EDUCATION REGULAR MEETING May 22, 2017

The Long Hill Township Board of Education held a Regular Meeting on Monday, May 22, 2017 in the Long Hill Township Town Hall. The meeting was called to order by Board President Nicholas Stevens at 7:30 p.m.

## ADEQUATE NOTICE OF MEETING:

Adequate notice of this meeting of the Long Hill Township Board of Education was given as required by the Open Public Meetings Act as follows:

Notice was sent to the Courier News, Echoes Sentinel and the Daily Record on October 27, 2016. Notice was posted on the bulletin board in the first floor entrance hall of the School District Administration Building, Gillette, New Jersey. Notices were filed with the Township Clerk; and notices were mailed to all persons who have requested individual notice pursuant to the Open Public Meetings Act.

COMMUNICATIONS: Dr. Acevedo thanked Mr. Villar for his service and wished him well in Warren. He noted that he received many letters and emails from parents who praised Mr. Villar.

# **BOARD COMMITTEE REPORTS**

Finance Committee— Mr. Carn noted that the Committee met and all items are in order and recommended for approval. Mr. Esposito and Dr. Acevedo will meet this week with Parette Somjen Architects about potential projects.

PTO– Mr. Carn reported on a number of upcoming events, including Environmental Day, Colonial Day, the visiting author events, and the Teacher Appreciation lunches.

FORCE– Mrs. Butler reported that FORCE is looking for volunteers and she can be contacted if anyone is interested.

Buildings and Grounds Committee— Mr. DiGiorgio stated that the process surrounding the RFP for the cleaning and maintenance services is progressing. Mr. Stevens thanked the Committee members, Mr. Esposito and Dr. Acevedo for their hard work on the RFP.

### SUPERINTENDENT'S UPDATE

Dr. Acevedo reported on the following:

- -He stated that the Screenagers event was held on 5/17 and he thanked the PTO and guest speaker.
- -He met with parents regarding Mr. Villar's position and his replacement. A survey has been created and sent out to gather feedback.
- -Additional sections for kindergarten and second grade will be added for the next school year. 92 students are currently registered for kindergarten for next year.
- -He congratulated the students who won the poetry contest and thanked Mrs. Fragnito and Mrs. DeBiasse for their involvement.
- -He reported the results of the lead re-testing.
- -He noted that confidential information was shared with the newspaper and published. He read a statement which defended the district, its special education programs, and its budget.

Mr. O'Leary asked if there was a response to each complaint and Dr. Acevedo indicated there is a plan to reach out to each parent.

Miss Nyquist inquired about why there is no Board member included on the Principal Search Committee. Mr. Stevens requested that a Board member be placed on the Committee.

### **BUSINESS ADMINISTRATOR'S UPDATE**

Mr. Esposito reported on the following:

-He explained some of the changes in special education enrollment and expenses for next year.

#### COMMENTS FROM THE PUBLIC

At this point, the Board of Education welcomes comments from any member of the public. Please note that as per Board Policy #1130, a total of fifteen (15) minutes is allocated for public comments at any single Board meeting. In order to provide residents the opportunity to comment, individual speakers are limited to three minutes each at any particular Board meeting. The Board may extend these time limits at its discretion.

Mrs. Falvey, a parent, thanked the Board for adding sections to kindergarten and second grade for next year. She praised the district for its high standards and for listening to the parents and their voices.

Ms. Duryee, a parent, thanked the Board for adding a 2<sup>nd</sup> grade section which will benefit the students. She talked about her daughter's preschool experience and is grateful to the child study team members. She wants a full-time special education director who can be fully dedicated solely to Long Hill's students and their needs.

Mrs. Novak, a staff member, wrote a letter to the Board in support of Brookwood Consulting and the child study team. She refuted the negative comments and quotes and is confident that the special education programming addresses the needs of every child. She gave examples of the positive actions that Ms. Yavelberg has taken to benefit the children.

Mrs. Schmitz, a special education teacher, supported Ms. Yavelberg's work in Long Hill and provided examples of her initiatives. She stated that Ms. Yavelberg implemented a number of programs the district never had.

Ms. Bennett, a parent, stated that her child has made tremendous strides and is grateful for the services he received. She is grateful to Ms. Yavelberg.

Ms. Cunningham, a teacher, stated that Ms. Yavelberg has introduced many innovative ideas and she fully supports her staff.

Mr. Villar, speaking on behalf of the Administrators, praised Ms. Yavelberg's work in the district and noted that she is always available even though she only works part-time in Long Hill.

Ms. Gans, a staff member, spoke in support of Ms. Yavelberg and was impressed with her knowledge of special education law. She noted that Ms. Yavelberg brought in students from other districts who paid tuition to Long Hill.

Mrs. Franklin, LHEA President, is pleased with the special education services her child receives as a student in Long Hill. Of those in attendance, she asked who was there to support Ms. Yavelberg and most of the audience stood up. LHPEC met and she attended the meeting. A speaker talked about ADHD but the leadership talked about obtaining information under OPRA. She raised the issue of a potential conflict as Mr. O'Leary is on the Board and his wife is a member of the Committee criticizing Ms. Yavelberg.

Mrs. Giannattasio, a parent, stated that she had problems with Ms. Yavelberg. Her child missed six weeks of speech and she was upset. She took him out of the extended school year program because she didn't feel it helped him. She hired an advocate and attorney and considered suing the district. She said she had to fight Ms. Yavelberg to get services for her child.
