## **ASSIGNMENT; TRANSFER**

The Chief School Administrator (CSA) shall make certified staff assignments in the manner best calculated, in his/her judgment, to enhance the educational program.

Teaching, supervisory and support personnel are subject to assignment and transfer after recommendation of the CSA and approval by the Board of Education (BOE). Procedures for such transfers shall comply with provisions of current negotiated agreements and state and federal law. Disciplinary transfers are prohibited. Particular attention shall be paid to ensuring, to the extent possible, that there shall be equivalence of teachers and administrative staff among the schools. Discrimination in assignment, transfer and promotion shall not be tolerated.

The CSA or his designee shall monitor district promotion, assignment and transfer practices to ensure nondiscrimination.
